## **Ensure Financial Sustainability**

**Goal:** Build a long-term foundation of financial health through endowment growth, annual stewardship, and informed generosity

## **Invest in Infrastructure & Campus Expansion**

**Goal 1:** Finish the 2019 Master Plan for campus expansion, ensuring facilities are welcoming, functional, and debt-free

**Goal 2:** Strengthen Rumble's governance, staffing, systems, and volunteer leadership to support future growth and engagement




# Sample Tactics

## **Build Community and Belonging**

- Build a mentor program for new members that assigns a “seasoned” member to a new family to encourage engagement with Rumble programs. Assigned to New Member Committee for Action in 2026

## **Deepen Christian Faith Formation and Practice**

- Call a full-time Associate Pastor who will have primary responsibility for Faith Formation of all age groups. Assigned to Personnel Committee (and a to-be-formed Associate Pastor Nomination Committee) for Action in 2026

# Sample Tactics

## **Ensure Financial Stability**


- Review documentation of all existing Endowment programs and accounts; identify and outline eligible uses, restrictions, and grantees. Assigned to Ad Hoc Endowment Committee formed for this purpose for Action by June 30, 2026

## **Invest in Infrastructure and Campus Expansion**

- Begin working on the facilities-use plan for the Fellowship Hall so staff can plan and promote accordingly. Assigned to Properties Committee with Rumble Staff for Action in late 2026 and early 2027
